PRELIMINARY REPORT

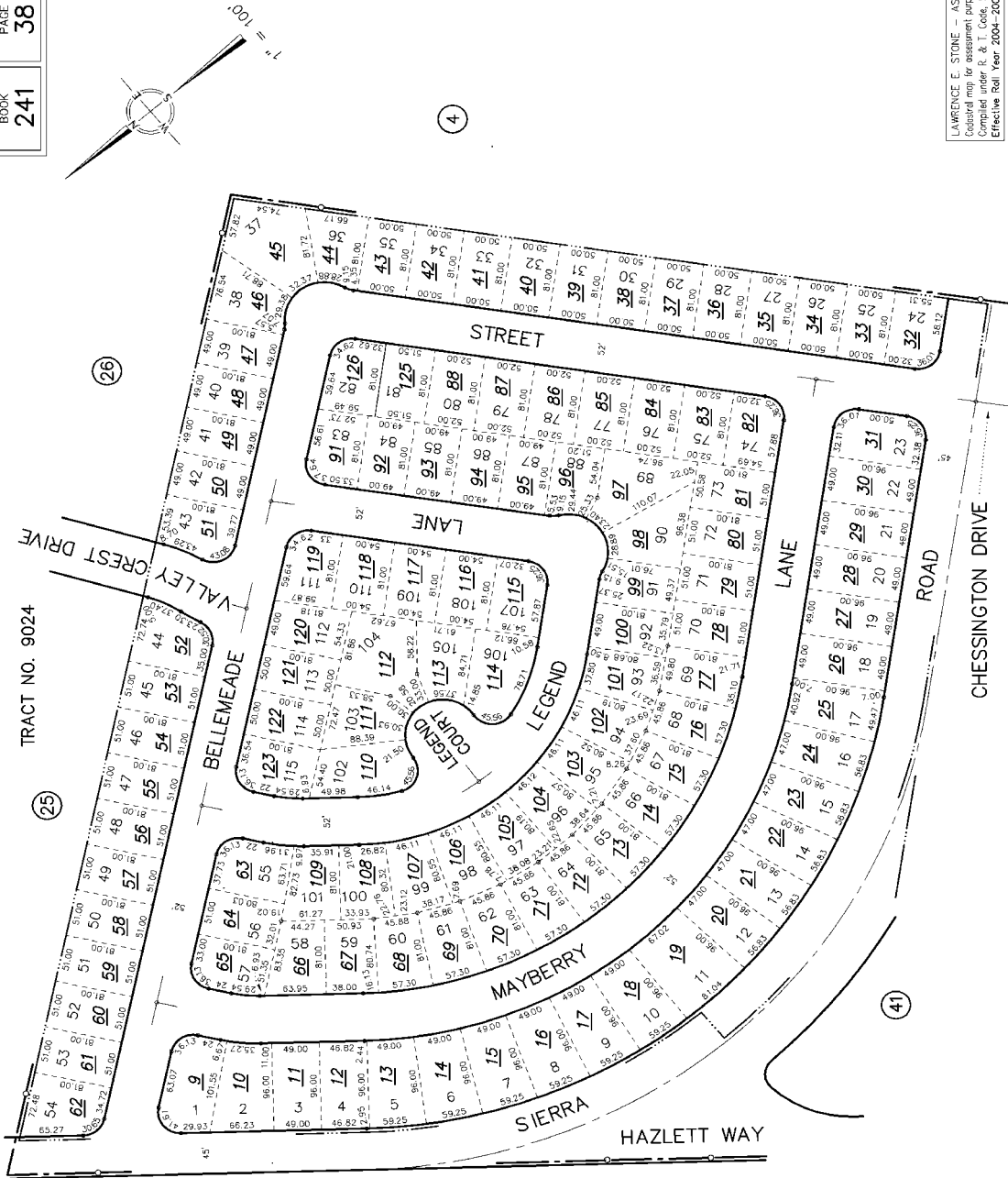
